## **Datenschutzerklärung – Privacy Act – Declaration of Data Protection**

We take the protection of your personal data seriously. In this privacy policy we would like to inform you in detail which data of the users of this website are collected, processed and used for which purposes.

### 1. Who is responsible for your data?

The legal collection, processing and use of your data is the responsibility of the owner of the Touch Oriental Spa Studio.

### 2. What data is collected for what purposes?

#### 2.1 User data

When you visit this website, the server automatically saves different data as follows:

- date and time of the request,
- name of the requested file,
- page from which the file was requested
- the type of browser used and the browser version,
- the operating system used,
- access status (file transfer, file not found, etc.),
- full IP address of the requesting computer,
- if applicable, a link that leads you to the page
- transferred amount of data.

This user data is used to make the website accessible to you, to detect and remedy any technical problems that can arise and to prevent and, if necessary, to track the misuse of a proposal.

#### 2.2 Data that you submit to us

You have the opportunity to contact us via e-mail. The personal information you provide to us in this context will be used solely to process your particular requests.

#### 2.3 Legal basis

The legal basis for the processing of your data is Art. 6 para. 1 lit. b, c, e or f of the European General Data Protection Regulation in conjunction with §§ 3 ff. Landesdatenschutzgesetz Rheinland-Pfalz.

### 3. Using Google Maps

Google Maps API, a map service of Google Inc. ("Google"), is included on this website for the purpose of displaying an interactive map. By using Google Maps, information about your use of this website (including your IP address) may be transmitted to and stored by Google on servers in the United States.

It would be technically possible for Google to identify at least one user based on the data received. It could also be that personal data and profiles of users of the website are processed by Google for other purposes. This and the fact that data is transmitted to the US, is problematic for data protection reasons.

You can easily deactivate the service of Google Maps and thus prevent the data transfer to Google: Disable JavaScript in your browser. However, please be aware that in this case you cannot use the map display.

### 4. When will data be shared with third parties?

Your data will only be disclosed to third parties without your permission, if there is an obligation by law or an authorized official request or court order.

### 5. Where is your data stored?

The processing of your personal data takes place exclusively in the Touch Oriental Spa department in Landstuhl.

### 6. How long will my data be stored?

Personal data will be deleted if that pertinent information is no longer required for the purposes described in this declaration, unless statutory provisions propose a longer storage period.

### 7. What rights do I have regarding the processing of my data?

You and any other persons affected by the use of the data are entitled to information about the personal data stored by us and, if the respective legal prerequisites are met, to claim for correction, deletion or restriction of processing.

You and the other data users also have the right to receive your personal information in a structured, common and machine-readable format. This includes the right to transfer this data to another responsible official. If this is technically possible, you and another respective data user may also demand from the stated date that the personal data be transmitted directly to the other person responsible.

In order to exercise your rights as well as in case of questions and complaints regarding the use of your personal data, you and the other persons concerned can always contact our data protection officer confidentially via our massage practice.

With complaints about the use of data by us, you and the other persons concerned can also contact the responsible supervisory authority:
